**Further, I understand that as a parking permit holder the Valley View Local School District's Random Urine Drug Testing Policy will apply to me**, and that properly completed Random Urine Drug Testing Consent Forms (by both parent and participant), Emergency Medical form, and Code of Conduct certification, must be submitted to the attendance office prior to purchase of a parking pass. Failure to have completed consent forms on file renders a parking pass invalid.

I know that driving to and from school is a privilege and to maintain that privilege I must drive in a safe and courteous manner. Parking Permits may be revoked temporarily or permanently at the administration's discretion.

I understand that to maintain my parking permit privileges that:

- I must properly display my valid 2020-21 parking permit while on school grounds;
- I must park inside the lines of my numbered parking space;
- I must enter and depart the parking lot in a safe, courteous, and orderly manner through the painted lanes;
- I must obey all applicable legal restrictions of a probationary driver license including passenger restrictions (16 & 17 year olds);
- I may lose my parking permit privileges for any violation of the VVHS Code of Conduct, including but not limited to attendance, excessive tardiness, or a violation of any stipulations in this agreement or the spirit of this agreement, driving safety, or any behaviors determined to put health and/or safety at risk;
- Some other examples of situations/behaviors for which driving privileges may be revoked are: receiving a moving violation or warning while driving to or from school (or otherwise violating driving laws), failure to secure seatbelt & have passengers do same, failure to follow all laws related to my age regarding the use of electronics while driving (texting, calling, etc.), being reported as driving in an unsafe manner by a credible source (as determined by administration), exceeding limits of passengers, engine revving, spinning/squealing tires, unnecessary horn blowing; transporting anyone in the back of pick-up truck, participating in 'car surfing', abuse of car pass, and inappropriate changing of clothes in/around cars.
- Student vehicles (whether owned by the student or parent/guardian) are subject to search while on school property or at school functions. Refusal to allow access to my vehicle for a search is viewed as insubordination and may result in my suspension and/or expulsion from school.
- Police dogs may be used to detect/alert illegal substances in vehicles on school property.
- I may not loan, sell, gift, or trade my parking permit without administrative approval.
- The speed limit on school property is 10 mph.
- I realize parking permit rules encompass driving to or from school for class, or any school function, as well as on school property.
